Course Content:

Topics may include:

- The formation of contract
- The construction of contract;
- Terms (construction and classification) and exclusion clauses including statutory terms), exclusion clauses, regulation of unfair terms;
- General law vitiating factors and codification of unconscionable conduct;
- Contractual discharge;
- Misleading or deceptive conduct prohibition;
- General law contract remedies and statutory remedies.
