Description of the Unit:

This is the second in the sequence of two Professional Inquiry units, in which candidates complete their professional inquiry project. Project outcomes should typically have clear recommendations for practice changes/improvements in the student's professional context. Candidates are expected to present a small small-scale study project with a written report. The process of inquiry is carefully planned to enable candidates to find a possible solution to their identified problem or greater understanding of the issue. Students professional inquiries are able to select from the following possible methodologies: 1. Survey Research; 2. Case Study; 3. Interview/focus group; 4. Document analysis; 5. Quantitative analysis of de-identified data; 6. Systematic/scoping/thematic review* (*with faculty permission)
