## **Description of the Unit:**

This modular unit will equip students with knowledge and skills to support the advancement of their clinical practice. This unit will foster professional development relevant to a variety of specialist and emerging practice domains. The learning activities within the unit will enable in-depth critical examination of the complexities of contemporary and future occupational therapy clinical practice. As part of each module, students will engage in targeted reflection of their capabilities against the Australian Occupational Therapy Competency Standards . The modules equip students to undertake autonomous evidence-based practice in regional Australia. The modules will be offered in a semi-block mode across the semester to enable immersion in specialised areas of practice.
