## **Description of the Course :**

The aim of this course is to provide practical experience in the application and practice of clinical psychology to students who have obtained a minimum of an intermediate level of clinical competency. This course is conducted within either the Federation University Community Psychology Clinic or an approved external agency. Students in this course are under the guidance of the course coordinator and the direct supervision of an individual AHPRA registered Clinical Psychology Supervisor within their placement location. The focus of this course is on extending the students' development of their practical skills and competencies through the experience of undertaking actual psychological work within a real world setting, as required, to achieve registration as a psychologist with the AHPRA Psychology Board of Australia upon successful completion of the Master of Clinical Psychology Program.

### **Course Content:**

Topics may include:

- Provision of an intermediate level professional experience in clinical psychology over a period of 50 days (students at this level will require routine supervision in the clinical work undertaken)
- All practicum work will be undertaken in either the Federation University Community Psychology Clinic or an approved external agency which offers clinical psychology services

- Direct client contact will be a major component of this practicum
- Individual and group (if applicable) supervision will be provided by suitably qualified and registered AHPRA endorsed Clinical Psychologists
- A daily activity Logbook, recording all psychological activities undertaken by the student will be kept
- A Supervision Logbook record will be kept detailing the content of discussions and reflections within supervision meetings of the clinical work undertaken by the student
- Completion of a case analysis report of an actual client with whom the student has worked

#### Values:
