Description of the Course :

On successful completion of the coursework components, candidates will be invited to progress to the research phase and prepare a research proposal for confirmation of candidature. Once confirmed they will proceed with their research and prepare a professional thesis for examination. This professional thesis will be based on a research-based project addressing important problems or question concerning policy and/or practice in a profession or industry. The thesis will make a contribution to knowledge, demonstrate an understanding of the relationship of the investigations undertaken and demonstrate critical reflection and analysis of issues relevant to professional policy and/or practice. The professional thesis will normally be 45,000 words.

This course is for use by candidates who are undertaking the research phase of the DBA on a parttime basis. It is worth 30 credit points, therefore the equivalence of studying 2 courses in the semester. Candidates have six semesters of part-time study to finish the research phase enrolling in BUGEN9102 each semester, (having made satisfactory progress) candidates will receive an 'O' result in the interim semesters. The final semester result should reflect a graded outcome following examination of a thesis submitted by the candidate.

Course Content:

This professional thesis/dissertation will be based on a research-based project addressing an important problems or question concerning policy and/or practice in a profession or industry. The thesis/dissertation will make a contribution to knowledge, demonstrate an understanding of the relationship of the investigations undertaken and demonstrate critical reflection and analysis of issues relevant to professional policy and/or practice. The professional thesis/dissertation will normally be 45,000 words.

Initial admission to the research component of the DBA program is on a probationary basis, and a Confirmation of Candidature must be achieved within 3 months of commencing the research

component full-time.
